These terms of use govern user's access to the portal (as defined below) for the limited purposes set forth below. The portal is the property of SGK. Conditioned on User's acceptance of these Terms of Use, SGK grants User limited access to the Portal solely for use in connection with the Purpose (as defined below). The Portal provides the ability for two way communication between SGK and the SGK client by whom User is employed or engaged as a contractor, and serves exclusively as a secure environment to transmit files, documents, specifications, engagement instructions, and other information in support of the artwork supply chain (the "Purpose"). User shall only access the Portal for the Purpose on behalf of the SGK client by whom User is employed or engaged as a contractor.

2. REVISIONS TO THESE TERMS OF USE

The Effective Date of these Terms of Use is set forth at the top of this webpage. SGK reserves the right, in our sole discretion, to modify these Terms of Use at any time without prior notice to User. SGK will post the modified version of these Terms of Use on the Portal and any modification is effective immediately upon posting. Each time User visits the Portal, User should check the Effective Date of these Terms of Use and review any changes made since the last time User visited the Portal. User's continued use of the Portal following any modification to these Terms of Use will be conclusively deemed to signify User's acceptance of the modification.

3. PROPRIETARY MATERIAL & CONFIDENTIAL INFORMATION

The Portal contains copyrighted material, trademarks, service marks, trade names, trade dress and other proprietary material, both registered and unregistered, belonging to SGK, our affiliates, licensors, and others that are protected by patent, copyright, trademark, and other intellectual property laws (the "Proprietary Material"). 9. INDEMNIFICATION

User agrees to indemnify, defend and hold harmless SGK and its officers, directors, employees, agents, affiliates, subsidiaries, suppliers, licensors and third party partners from and against all claims, losses, expenses, damages and costs, including reasonable attorneys' fees, arising out of User's use of the Portal, User's violation of these Terms of Use and User's violation of any rights of third parties.

10. DISPUTE RESOLUTION

In the event of any controversy, dispute or claim arising out of or related to the use of the Portal or the Proprietary Material, the controversy, dispute or claim shall be resolved exclusively by binding arbitration in accordance with the then-current Commercial Rules of the American Arbitration Association. However, SGK will have the right to petition any court of competent jurisdiction for the entry of injunctions and orders for specific performance relating to User's unauthorized use of the Portal or the Proprietary Material.

11. GOVERNING LAW

These Terms of Use will be governed by the laws of the Commonwealth of Pennsylvania, without regard to conflict of laws principles. Except as provided in Section 10 of these Terms of Use, all litigation and other proceedings initiated in connection with the Portal or the Proprietary Material will be venued exclusively in the state or federal courts located in Pittsburgh, PA.

12. MISCELLANEOUS

If any provision of these Terms of Use is held to be invalid, illegal or unenforceable under applicable law, then the invalid, illegal or unenforceable provision shall be deemed superseded by a valid, legal and enforceable provision that most closely matches the intent of the original provision and the remainder of these Terms of Use shall continue in effect.
